Day 1: Departure

Today we depart on our flight to Paris. Inflight meals as provided by the airlines.

Day 2: Paris to Normandy

Upon our arrival in Paris, we board our motor coach and transfer to Normandy. Enroute we visit the **Peace Memorial** in **Caen**, dedicated not only to the Normandy invasion, but to the international cause of peace. We continue on to Bayeux, where we will spend the next two nights. **D**

Day 3: Normandy

A busy day is on the agenda today as we explore the sites of the D-Day invasion; the greatest amphibious assault ever attempted and the beginning of the end for Hitler's Third Reich. Our local guide will take us on an excursion including **Utah Beach**, the site of the first allied beach landings on D Day. Here we start to understand the chaos of war and how American leadership and the GI's initiative would overcome it. We will also visit **Ste Mere Eglise** considered to be the first town liberated in France on the 6th of June and also depicted in the film *The Longest Day*. After lunch on our own, we continue on to **Omaha Beach**, its cemetery and visitor center of **Pointe du Hoc**, and the artificial harbor at **Arromanches**. We return to Bayeux for overnight. **B**

Day 4: Paris

Today we drive to Paris, the City of Lights. Upon arrival in the afternoon, we enjoy a locally-guided panoramic tour of Paris including its renowned landmarks: the Arc de Triomphe, Eiffel Tower, Place de la Concorde, and the Champs-Élysées. Our tour includes an inside visit to Notre Dame Cathedral. After checking into our hotel, we enjoy a dinner cruise on the Seine. **B/D**

Day 5: Paris, train to Venice

Our morning is free to explore this historically and culturally rich city on our own. The possibilities are endless. Art lovers with an interest in Impressionism will want to visit the Museums d'Orsay and de l'Orangerie des Tuileries with their works by Van Gogh, Monet, and Cezanne among others. Photographers gain a spectacular city view from the top of the Eiffel Tower. For shoppers there are the famed department



stores Lafayette and Printemps. And for people watchers, a stroll along the banks of the Seine or seated at a sidewalk café in the Latin Quarter is just the ticket. We check out of our hotel at noon and spend the afternoon in Montmartre, home to the Moulin Rouge and the impressive Sacré-Coeur Basilica. This evening, we board an overnight train to Venice. **B**

Day 6: Venice

This morning our train arrives in fabulous Venice—La Serenissima, the "Serene One" at the Santa Lucia station at 9:35 a.m.. Built upon 117 islands, Venice is a mosaic of canals, plazas, fascinating markets, and chaos! After checking into our hotel, we begin our tour of Venice with a cruise along the serpentine **Grand Canal**, ending at **St. Mark's Square**. Our local guide shows us **St. Mark's Basilica** and its unforgettable mosaics as well as the **Doge's Palace** with its splendid rooms, dark dungeons and the famous **Bridge of Sighs**. We have time in the afternoon to explore and shop in the famous market area around the **Rialto Bridge** or to enjoy a coffee and some people-watching at St. Mark's Square. **B/D**


Day 7: Lake Maggiore

Today we depart Venice by motorcoach and travel north to the Lake District of Italy. The most famous of these are Lakes Como, Garda, and Maggiore. Stresa on Lake Maggiore is our destination for the day. In the afternoon, we travel by ferry from Stresa to **Isola Bella** and tour the **Palazzo and Gardens** there. The complex was built as a fantasy palace by the Borromeo Family in the 16th century and has been an attraction for visitors from the beginning. We return to Stresa for the evening. **B/D**

Day 8: Interlaken

Before we depart Italy this morning, we travel by **cable car to Mottarone** and enjoy a panoramic view that includes the Lake District and the Alps. We then continue by motorcoach over the Alps to Lauterbrunnen, Switzerland, where we view the **Trümmelbachfälle**, several waterfalls within a mountain that drain nearby glaciers. The raw power and beauty of the falls have attracted tourists for decades. Finally, we drive to Interlaken to check into our hotel. **B/D**

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Airline tickets once written are usually nonrefundable.

- ⇒ Up to December 18, 2016: \$50 per person administrative fee will be assessed
- ⇒ Dec. 19, 2016 to March 18, 2017: \$150 per person plus any lost land and air deposits will be assessed
- ⇒ From March 19, 2017 to June 2, 2017: \$350 per person plus any lost deposits on land and air will be assessed
- ⇒ After June 3, 2017: No Refund

Day 9: Interlaken (Jungfrau)

A day in the mountains awaits us today. We board a train for a scenic ride through the Lauterbrunnen Valley. Upon arrival in Lauterbrunnen, we board a **cogwheel train** to Wengen, a town without cars halfway up the mountainside. Here, we take a short walk through the town to the cable car station, where we take a gondola up to the **Männlichen**. At the Männlichen, we can enjoy the magnificent alpine scenery in the panoramic restaurant, or we can hike in the area. Later, we board the **cable car** for our descent to Wengen and finally the **cogwheel train** to Lauterbrunnen and then back to Interlaken. **B**

Day 10: Interlaken

We enjoy a free day in Interlaken for shopping and sightseeing. Some may choose to relax in a spa, while others could take a cruise on Lake Brienz or Lake Thun. We meet again later for our farewell dinner in a local restaurant. **B/D**

Day 11: Return (from Zürich)

It is time to bid farewell to Europe as we transfer to Zürich for our international flight home. **B**
